ARTICLES OF INCORPORATION

OF

CAPITAL SERVICES, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being all natural persons of legal age and all citizens of the United States and all residents and citizens of the State of Idaho, in order to form a corporation of the State of Idaho, do hereby certify as follows:

1.

The name of the corporation is CAPITAL SERVICES, INC.

2.

That the said corporation is formed for the following purposes:

- a. To own, buy, sell, develop, lease and manage business of any and all varieties and business properties of any and all varieties and to engage in all activities incident thereto.
- b. To receive, acquire, hold, purchase, dispose of, convey, mortgage and/or lease, real and personal property; to dispose of, sell, lease, assign, transfer, mortgage and/or convey any rights, privileges, franchises, real or personal property of the corporation, other than its franchises, real or personal property of the corporation, other than its franchise of being a corporation, and to acquire, purchase, guaranty, hold, mortgage, own, vote, sell, pledge and/or otherwise dispose of and deal in shares, bonds, securities and indentures and other evidence of indebtedness of its own and of other corporations, domestic or foreign.

- District of Columbia, territories and colonies of the United States and in foreign countries, and to have one or more offices and places of business out of this state, and to acquire, receive, hold, purchase, lease, mortgage, dispose of and/or convey real and personal property situated out of this state.
- d. To do any and all such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient or auxiliary to any of the objects herein before enumerated, or calculated, directly or indirectly, to promote the interest of the corporation; and in carrying on its purposes, or for the purpose of obtaining or furthering any of its business.
- e. To enter into, make, perform and carry out contracts of
 every kind and for any lawful purpose, without limit as
 to amount, with any person, firm, association, corporation,
 municipality, state or government, or any subdivision,
 district or department thereof.
- f. The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in each clause shall be in nowise limited or restricted, by reference to, or inference from, the terms of any other clause, but shall be regarded as independent purposes and powers; and no recitation, expression or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive; but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

The corporation is to have a perpetual existence.

The capital stock of said corporation shall be Ten

Thousand Dollars (\$10,000.00) to be represented by One Thousand
