ARTICLES OF INCORPORATION

The undersigned, a citizen of the United States and resident of the State of Idaho, and of legal age, acting an incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be Rodeo Partners, Inc.

ARTICLE II

The duration of the corporation shall be perpetual. The location and address of the registered office in the State of Idaho shall be 479 N. Curtis Road, P.O. Box 9444, Boise, Ada County, Idaho 83707. The registered agent is Reed B. Peterson.

ARTICLE III

The aggregate number of shares which the corporation shall have the authority to issue is 100,000 of Common Stock of the par value of \$1.00 per share. All of the Stock shall have the same powers and voting rights and shall be nonassessable for any purpose whatsoever.
