1. Paragraph number three (3) of the original Certificate of Limited Partnership for Paul C. Holm Limited Partnership shall be amended to read as follows:

3. Registered Agent.

2. Paragraph number ten (10) of the original Certificate of Limited Partnership for Paul C. Holm Limited Partnership shall be amended to read as follows:

10. No other right to distribution.

There is no other right of a partner to receive distributions to a partner, whether by way of return of all or any part of the

partner's contribution; provided, however, that the general partners may, at their sole discretion and at any time when authorized by written resolution executed by the general partners or their duly appointed agents acting under a valid general power of attorney, make a partial distribution of the capital assets of the partnership to the partners. Such a partial distribution of partnership capital assets shall not cause a dissolution of the partnership and shall not otherwise effect the general partners' duty to distribute income from the remaining partnership capital assets as provided elsewhere herein.

3. All other provisions of the certificate of limited partnership for the Paul C. Holm limited partnership shall remain in full force and effect.






