AMENDMENT TO ARTICLES OF INCORPORATION OF WAREMART, INC.

BE IT KNOWN, that we, the undersigned, the President and Secretary, respectively, of WAREMART, INC., do hereby certify in accordance with the provisions of Section 30-146, Idaho Code, as follows:

1. That by written consent signed by the holders of all the issued and outstanding stock of WAREMART, INC., as of March 15, 1972, pursuant to Section 30-146(5), Idaho Code, said shareholders authorized and consented to the amendment of the Articles of Incorporation of WAREMART, INC., as follows:

"That Article NINTH of the Articles of Incorporation of WAREMART, INC. be amended by deleting the entire Article and inserting in place thereof, the following Article NINTH:

'NINTH

The stockholders of the corporation shall have no preemptive or preferential rights of subscription to any shares of stock of the corporation, whether now or hereafter authorized, or to any obligations convertible into stock of the corporation.

2. We do further certify that the undersigned are authorized, empowered, and directed by the shareholders in said written consent to cause proper Articles of Amendment to the Articles of Incorporation to be prepared, executed, and filed as provided by the laws of the State of Idaho.
