ARTICLES OF INCORPORATION

OF

SAKO FARMS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME: The name of the corporation is SAKO FARMS, INC.

ARTICLE II

DURATION: The period of its duration is perpetual.

ARTICLE III

<u>PURPOSES</u>: The purposes for which the corporation is organized are:

- 1. To engage in a general agricultural farming, fruit growing, and farm operation business.
- 2. To engage in the business of growing, producing and marketing of agricultural products and fruit of every type and nature, including the packing and sale thereof.
- 3. To engage in the transaction of any or all other lawful business for which corporations may be incorporated under the provisions of Chapter 1, Title 30 of the <u>Idaho Code</u> and any amendments thereto.

ARTICLE IV

STOCK: The aggregate number of shares which the corporation shall have authority to issue is 10,000. Said stock shall be of one class designated as common stock with a no par value.
