**RESOLUTION OF THE MEMBERS**  
**Friends of the Shelter, Inc.**

**WHEREAS** the Corporation has been offered a donation of land and improvements for a new animal shelter from the Wild Rose Foundation; and

**WHEREAS** the Wild Rose Foundation's gift is contingent on the Corporation adopting a "no kill" policy; and

**WHEREAS** the Corporation has already adopted policies consistent with the "no kill" philosophy; and

**WHEREAS** the Articles of Incorporation do not address euthanasia; now, therefore,

**RESOLVED**, Article 4 of the Articles of Incorporation shall be amended as follows;

THIS CORPORATION is organized for purposes of sheltering and the adoption of homeless animals for the City of Sandpoint and the counties of Bonner and Boundary, Idaho. Any shelter facility owned, operated or supported by the Corporation shall have and abide by a "no kill" policy. Such policy shall provide that euthanasia may not be utilized except to alleviate extreme suffering and to destroy animals that pose an imminent danger to the health and safety of human beings or other animals. Such policy shall further provide that euthanasia may only be employed after all efforts to save the animal have been considered, including medical and behavioral rehabilitation, foster care, rescue groups, neuter and release, and adoption. Euthanasia in matters of aggression must be documented by Friends of the Shelter Inc. Manager, presented to the Animal Care Chair and supported by a majority vote of the Board of Directors. Any facility receiving an animal from Friends of the Shelter Inc. must agree by contract to comply with the euthanasia policy of Friends of the Shelter Inc.

**FURTHER RESOLVED**, Article 13 shall be added to the Articles of Incorporation and such article shall provide that:

The Bylaws shall be consistent with the Articles of Incorporation. Any provision contained in the Bylaws that is inconsistent with these Articles shall be deemed null and void.
