ARTICLES OF INCORPORATION

OF

BEAR LAKE BOWMAN CLUB, INC.

THE UNDERSIGNED, acting as incorporators of a corporation NON-DAGET under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is BEAR LAKE BOWMAN CLUB,

SECOND: The period of its duration is perpetual.

THIRD: This corporation is organized exclusively for community welfare and education of the public in conservation and use of the bow and arrow. The purpose for which the corporation is organized is the transaction of any and all lawful acts or activities for which a corporation may be organized under Idaho Code 30-1-3 of the Idaho Business Corporation Act of the State of Idaho as the same now exists or is hereinafter amended.

FOURTH: In lieu of capital stock, the corporation shall issue membership certificates to each member thereof which certificates cannot be assigned, except by resolution of the Board of Directors and under such regulations as the by-laws may prescribe.

FIFTH: Each member in good standing under the by-laws of the corporation shall be entitled to one (1) vote at the meetings of the corporation.

SIXTH: The location and post office address of the registered office of the corporation in the State of Idaho is:

EIGHTH: The method and manner of holding directors' meetings and corporation meetings, the authority and duties of each of the offices of the corporation and all other matters for management or control of the corporation shall be determined by the by-laws of the corporation and by the laws of the State of Idaho.

MINTH: These Articles of Incorporation may be amended in the manner provided by law and in conformity with Idaho Code 30-3-26. Every amendment shall be approved by and proposed by the Board of Directors to the corporation members and approved by the corporation members by an affirmative vote of a majority of those present at a meeting called for the purpose of voting upon proposed amendments.
