under the laws of the Territory of Idaho
pursuant to the provisions of the act
entitled "An Act concerning Corporations
approved January 13. 1875, and in com-
pliance with the provisions of said Act
we do hereby state and certify

First That the corporate name of
said Company shall be The Wood River
Improvement Company

Second The objects for which said
Company is to be formed are as follows
viz: the carrying on of a manufacturing
business, and the engaging in trade and
commerce, the business of making and per-
forming contracts or sub contracts with any
person or corporation having the power
capacity or franchise to build or construct
or operate railroads, reclamation works or
other works or improvements within the
said Territory of Idaho; the purchase
improvement, sale and exchange of real
and personal property of every kind in
any portion of the Territory of Idaho

for or by any corporation or person and by way of payment to receive or deliver in whole or in part money, or the securities of any government, or any corporation, whether such securities shall be bonds, mortgages, debentures, notes or shares of capital stock, and to sell the same, and for the purpose of said business to lease, purchase, hold, sell, assign convey and exchange real or personal property or contracts of every name and nature, and the doing of any other thing or the carrying on of any and all other business operations which may be necessary or advisable in connection therewith authorized or which may be authorized by the Laws of the Territory of Idaho under which this Company is to be formed

Third - That the amount of the capital stock of said Company shall be Twenty Thousand Dollars which shall be divided into Two Thousand shares of the par value of Ten Dollars each and which said shares when fully paid shall be forever unassessable

Fourth That the term of the existence of the said Company shall be fifty years

Fifth That the number of Trustees who shall manage the concerns and business of the said Company shall be three, and the names of such Trustees who shall manage the affairs of said Company for the first three months are
J. Mercer Garnett
James C. Weston and
Henry Weston

Sixth That the name of the Town and County where the principal place of business of the Company is to be located is Galena in the County of Alturas and Territory of Idaho, but a portion of the business and operations of the said Company shall be carried on outside of said Town of Galena

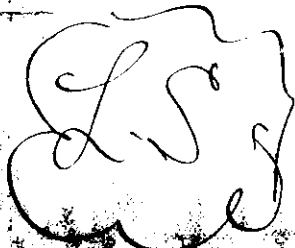
