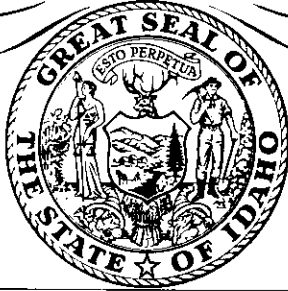

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all being of full age, and all citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the Business Corporation Act of the State of Idaho, and to that end we hereby adopt the following Articles of Incorporation:

ARTICLE I. The name of the corporation shall be KANIKSU LANES, INC..

ARTICLE II. The purpose of the corporation is to engage in the operation and maintenance of a bowling alley, restaurant, lounge, and such other facilities as may be necessary to operate in conjunction with said bowling alley; to lease, purchase and acquire such properties, both real and personal, as may be necessary and convenient for the operation and maintenance of said businesses. To engage in the retail sale of all types of bowling equipment and accessories, and to otherwise engage in, or deal in anything which might be deemed advantageous, beneficial, or desirable to further the purposes of this corporation, including, but not limited to the sale and dispensing of foods, beverages, and merchandise of all kinds.

ARTICLE III. The period of existence and the duration of the life of the corporation shall be perpetual.

ARTICLE IV. The principal place of business shall be Oldtown, Bonner County, Idaho; the post office address of its registered office shall be Priest River, Idaho.

ARTICLE V. The stock of the corporation is divided into 250 shares of common stock at \$100.00 par value each.

ARTICLE VI. The total authorized number of par value shares is 250. The aggregate par value of the total authorized number of par value shares is \$25,000.00.
