ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
GRAPHIC ARTS PUBLISHING, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The present name of the corporation is Graphic Arts Publishing, Inc.

SECOND: The following amendment of the Articles of Incorporation was adopted by unanimous written consent of the sole shareholder of the corporation in accordance with the provisions of Idaho Code §30-1-145 on January 4, 1988, in the manner prescribed by the Idaho Business Corporation Act:

"BE IT RESOLVED, that the name of the corporation be changed from Graphic Arts Publishing, Inc., to Tribune Web Printing, Inc., and that Article I of the Articles of Incorporation of the corporation be, and the same is hereby, amended by deleting said article as now written and substituting in lieu thereof the following:

"ARTICLE I.

"The name of this corporation is, and shall be, Tribune Web Printing, Inc."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was twenty-two thousand eight hundred (22,800) shares of a single class of common stock; the number of shares entitled to vote thereon was twenty two thousand eight hundred (22,800) and the resolution hereinabove

set forth was duly adopted by the written consent of the holder of said twenty two thousand eight hundred (22,800) shares as more particularly provided in Idaho Code §30-1-145.
