of the

Recorded as the
Settlers Ditch Co.

Know all Men by these Presents:

That we the undersigned, a majority of whom
are Citizens and residents of the State of Idaho
have this day voluntarily associated ourselves
together for the purpose of forming a Corporation
under the laws of the State of Idaho.

And we hereby Certify:

First. That the name of said Corporation
shall be The Squaw Creek Ditch Company.

Second. That the purposes for which it is formed
are for irrigation.

Third. That the place where the principal bus-
iness of said Corporation is to be transacted is
Sweet, Idaho.

Fourth. That the term for which said Corporation
is to exist is fifty years years, from and after
the date of its Incorporation.

Fifth. - That the number of Directors or Trustees
of said Corporation shall be three and that the names
and residences of the Directors or Trustees, who are
appointed for the first year and to serve until
election and qualification of such officers, are
as follows, to-wit:

3 and the number of shares into which it is divided
