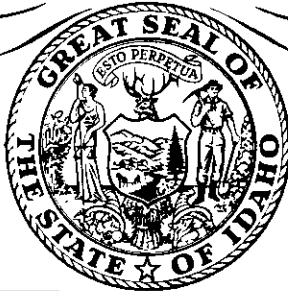

### CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho do hereby certify that the original of the articles of incorporation of

#### ATLAS MANUFACTURING COMPANY, INCORPORATED

was filed in the office of the Secretary of State on the **Eighth** day of **April** A.D. One Thousand Nine Hundred **Sixty-three** and duly recorded on Film No. **123** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Caldwell** in the County of **Canyon**

2 ARTICLE III

3 The existence of this Corporation shall be perpetual.

4 ARTICLE IV

5 The location of the registered office in this state shall  
6 be located in Caldwell, County of Canyon, Idaho, and the Post  
7 Office address shall be 1308 Arlington Avenue, Caldwell, Idaho.

8 ARTICLE V

9 The total authorized number of par value shares is twenty-  
10 five thousand (25,000) and their aggregate par value is Five  
11 Thousand (\$5,000.00) Dollars. Par value per share is Twenty  
12 Cents (20¢). The Corporation has not authorized the issuance  
13 of any no par value shares of stock.

14 ARTICLE VI

15 There shall be only one class of stock, and it shall be  
16 designated as common stock. The shares of stock shall not be  
17 issued until payment in full has been received, and such stock  
18 shall be nonassessable stock and the face of the certificate  
19 shall state on its face that it is nonassessable stock and the  
20 shareholders shall have no liability for corporate obligations.  
21 Each share of stock shall have the voting rights as now or  
22 hereafter granted by the laws of the State of Idaho relating  
23 to corporations.

24 ARTICLE VII


