ARTICLES OF INCORPORATION OF MCQ 1, INC.

The Articles of Incorporation of MCQ 1, Inc. are in their entirety as follows:

Article 1 NAME OF THE CORPORATION

The name of the corporation is MCQ 1, Inc. (the "Corporation").

Article 2 PURPOSES OF THE CORPORATION

The Corporation is organized for the purpose of transacting any and all lawful business for which a corporation may be incorporated under the Idaho Business Corporation Act.

Article 3 SHARES

- 3.1 Stock. The aggregate number of shares the Corporation is authorized to issue shall be 100,000 shares of voting common stock (without par value).
- 3.2 Treasury Shares. Unless a resolution of the Board of Directors provides that reacquired shares shall constitute authorized but unissued shares, any shares reacquired by the Corporation shall be treasury shares and may be held, used, resold, or disposed of free of any restrictions that would be imposed on the original issuance of shares of the Corporation.
- 3.3 Preemptive Rights. Shareholders of the Corporation shall have no preemptive rights to acquire stock in the Corporation.
- 3.4 Voting. Each outstanding share of stock shall be entitled to one (1) vote on each matter submitted to a vote at a meeting of shareholders, including election of directors of the Corporation and other corporate purposes. Shareholders of the Corporation shall not have the right to cumulate their votes for Board of Directors.

Article 4 REGISTERED OFFICE AND AGENT

The address of the registered office of the Corporation is 988 W. King Road, Kuria, Idaho 83634. The name of the registered agent at such address is John McNicholl. The mailing address of the Corporation is P.O. Box 160, Kuna, Idaho 83634.

Article 5 BOARD OF DIRECTORS

5.1 Initial Board of Director. The number of directors constituting the board of directors of the Corporation will be no less than one (1) and no greater than ten (10). Until changed as provided in the Corporation's Bylaws, the number of directors who constitute the

The Corporation shall indemrify the directors and officers of the Corporation to the fullest extent permitted by the Idaho Business Corporation Act, as the same exists or may hereafter be amended (but, in the case of any such amendment, only to the extent that such amendment permits the Corporation to provide broader indemnification rights than the Idaho Business Corporation Act permitted the Corporation to provide prior to such amendment).
