ARTICLE IV

The objects and purposes for which this corporation is formed shall be:

Any Christian Purpose for furthering the gospel of Jesus Christ And more particularly, to promote Christian Truth and Character among the people of our churches by means of Bible Camps, Conferences and Retreats for different age groups.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 503 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE XI

Dissolution

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
