Within these purposes, the corporation is formed to pursue the following specific objectives: (1) To enhance the health, safety and welfare of rural communities in the state of Idaho (defined as any Idaho city that is not listed in the top 10 of cities based on population as defined by the US Census Bureau) through enhancements or additions such as, for illustrative purposes only, playground equipment, police equipment, firetrucks, swimming pools, sporting equipment, and athletic facilities for local youth activities, but excluding any significant real property acquisitions; (2) To provide graduate and post-graduate scholarships for youths in such rural communities to attend University of Idaho, The College of Idaho, Lewis-Clark State College in Lewiston, Idaho, and from time to time but in a lesser degree, in the discretion of the Board of Directors, also to The Fountain Valley School of Colorado. |
