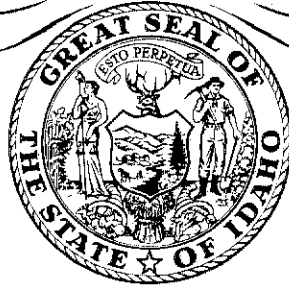

CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

MOUNTAIN VIEW SOUTHERN BAPTIST CHURCH OF BOISE, IDAHO, INC.

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **twenty-eighth** day of **May**, 19 **59**, original articles of amendment, as provided by Section **30-1103, Idaho Code, amending Article I, changing corporate name to MOUNTAIN VIEW BAPTIST CHURCH, INC. (SOUTHERN BAPTIST AFFILIATION),**

and that the said articles of amendment contain the statement of facts required by law, and are recorded on Film No. **107** of Record of Domestic Corporations of the State of Idaho.

CERTIFICATE OF AMENDMENT
OF ARTICLES OF INCORPORATION
OF THE MOUNTAIN VIEW SOUTHERN BAPTIST CHURCH
OF BOISE, IDAHO, INC.

We, the undersigned, duly elected, qualified, and acting trustees of the Mountain View Southern Baptist Church of Boise, Idaho, Inc., a religious corporation, do hereby certify that at a meeting of the members of said church corporation duly called and held on the 5th day of November, 1958, at which meeting a majority of the members were present, the following resolution amending the Articles of Incorporation of said Mountain View Southern Baptist Church of Boise, Idaho, Inc., was adopted by a Majority vote of said members, to-wit:

"Resolved that Article I of the Articles of Incorporation of the Mountain View Southern Baptist Church of Boise, Idaho, Inc., be and the same hereby is amended to read as follows:

ARTICLE I

NAME

The name of this corporation is Mountain View Baptist Church, Inc. (Southern Baptist Affiliation).

Resolved further that the trustees of this corporation be and they hereby are authorized and directed to make, execute, and acknowledge a certificate under the corporate seal of this corporation containing the foregoing resolution amending such Articles of Incorporation, and to file the same with the Secretary of State of the State of Idaho, and otherwise as required by law."

We further certify that said resolution and said Articles of Incorporation so amended at such meeting of the members of said corporation held on said date were duly adopted, ratified, and confirmed.
