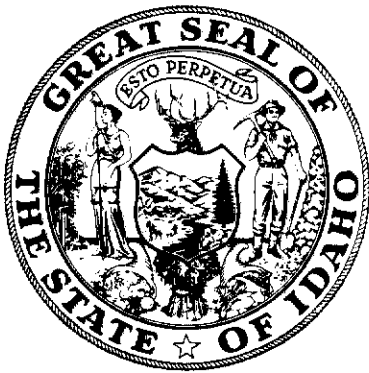

ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF

INTERMOUNTAIN EMERGENCY PHYSICIANS, INC.

The undersigned, in order to form an Idaho professional corporation for the purposes hereinafter stated, pursuant to the Idaho Professional Service Corporation Act, does hereby amend and restate the Articles of Incorporation for such corporation pursuant to Idaho Code §30-1-61. No shares have been issued and, therefore, these Articles of Amendment have been executed by the incorporator. These Articles of Amendment amend Articles I, II and VII of the Articles of Incorporation.

ARTICLE I

The name of the corporation shall be RICK D. LAMB,

ARTICLE II

The corporation is formed to engage in the practice of  
medicine.

ARTICLE III

The Corporation is to have perpetual existence.

ARTICLE IV
