The undersigned, acting as Incorporator of a corporation under the "Idaho Business Corporation Act," adopts the following Articles of Incorporation for such corporation.

The total number of shares of stock which the corporation has authority to issue is 1000 shares without par value, all of one class.


ARTICLE V

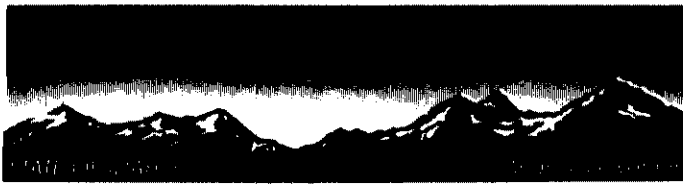
