The period of the corporation's duration is perpetual.

Without limitation, the specific purpose for which the Corporation is presently formed is to provide domestic water service to specifically described real properties, subject to the terms and conditions of these Articles of Incorporation, the Corporation's Bylaws, a certain Declaration of Water System, and such Rules and Regulations as may hereafter be adopted by the Corporation setting forth additional terms and conditions as to the provision of domestic water service to those entitled thereto. Any conflict in the Corporation's documents of organization or governance shall be resolved by giving preference to said documents in the following order: The Articles of

Incorporation, the Bylaws, the Declaration of Water System, and the Rules and Regulations hereafter

#### ARTICLE VI.

In the event the corporation is dissolved in conformity with Idaho law (the Idaho Non-Profit Corporation Act, I.C. §30-3-1, et seq., as it now exists or is hereafter amended), then any assets of the Corporation which remain after paying all corporate obligations and liabilities shall be liquidated and distributed to the Corporation's members (to be determined as of such date as the Corporation's Board fixes in its discretion) pro ratably.

## ARTICLE VII.

Membership in the Leaning Pine Water Association, Inc., shall be as defined in the "Declaration of Leaning Pine Water Association, Inc.," (referred to herein and in the Association's Bylaws as the "Declaration of Water System"). Additional memberships can be granted in the

Association by a majority of the Association's Members and said memberships shall be documented and reflected by recorded amendments to the Declaration of Water System. Proof of ownership of a member lot or property described in, and subject to, the referenced Declaration shall constitute sufficient proof of membership in the Association. Said membership shall run with and bind the member property as an appurtenance thereto. Any successor purchaser or transferee in and to said lot shall be entitled to membership in the Association and shall be responsible for all obligations arising therefrom.

# ARTICLE VIII.

Authorization of assessments to be levied upon all members of the corporation are herein granted. The Board of Directors are herein authorized to fix the amount and collection of assessments by such methods as are provided in, and consistent with, the Association's Bylaws. Assessments are enforceable by legal action as provided in the Bylaws.
