

## Article of Incorporation.

Known all Men by these presents that we, the undersigned, bona fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

### Article 1.

The name of this corporation shall be. The Juras Place Fruit Farm Company limited.

### Article 2.

The purposes for which this corporation is formed are to purchase, own and sell real-estate, purchase and sell fruit and vegetables, stock and poultry to carry on and manage a general farming fruit and stock raising business and to do and perform all things necessary to enable this company to carry out the objects herein set forth, and with full authority to enact by-laws for the guidance of its officers.

Article 3.

The place where the principal business of this corporation is to be transacted is at the office of this company in the City of Caldwell, Canyon County, State of Idaho.

Article 4.

The term for which this corporation is to exist is fifty years from the 1<sup>st</sup> day of March 1903.

Article 5.

The number of directors of this corporation shall be five, and the names and addresses of those who are to act for the first year are.

The amount of the capital stock of this corporation shall be Fifteen thousand dollars, (\$15,000<sup>00</sup>), divided into 15,000 shares of the par value of one dollar each.
