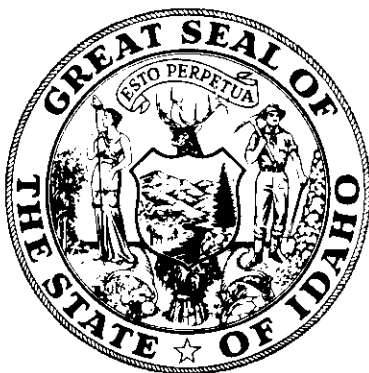

ARTICLES OF INCORPORATION

KRSP Services, Inc.

KNOW ALL MEN BY THESE PRESENTS:

I, the undersigned, being a natural person of majority age and a citizen of the United States of America, and in order to form a corporation for the purposes stated below, pursuant to the purposes stated below, pursuant to the Idaho Business Corporation Act, do hereby certify as follows:

1. NAME: The name of this corporation is KRSP Services, Inc.
2. DURATION: The corporation shall have perpetual existence.
3. PURPOSE: The purposes of the corporation are to engage in any or all lawful businesses for which corporations may be organized under the Idaho Business Corporations Act, including, but not limited to, service organizations for which membership will be required, in order for individuals to obtain services for which the corporation may qualify to provide.
4. REGISTRY: The initial registered office of the corporation is located at 5288 W. Blackrock, Inkom, Idaho 83245. The name of the initial registered agent of the corporation is LouJean B. Walker at that address.
5. STOCK: The total authorized number of par value shares of stock is five hundred ((500.00)). The aggregate par value of the total number of par value shares is Fifty Thousand Dollars (\$50,000.00). There shall be one class of shares, designated as "Class A Common Stock" which shall carry one vote per share.
