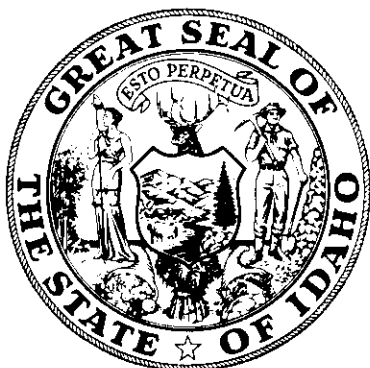

ARTICLES OF INCORPORATION

OF

GUIDED OUTDOOR ADVENTURE TOURS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

PROVISION I.

Name. The official name by which this corporation shall be known is GUIDED OUTDOOR ADVENTURE TOURS, INC.

PROVISION II.

Duration. The period of duration for the business activities of the above described corporation shall be perpetual.

PROVISION III.

Purpose. The purpose or purposes for which this corporation is organized is for the transaction of any or all lawful business for which corporations may be lawfully incorporated under the Idaho Business Corporation Act and the laws of Idaho.

PROVISION IV.

Stock. The aggregate number of shares which the corporation shall have the authority to issue is to consist of one class of common voting stock consisting of fifty thousand (50,000) shares with a par value of One Dollar (\$1.00) per share. In addition, there shall be no provisions denying preemptive rights to the initial stockholders.

PROVISION V.

By-Laws. All pertinent and relevant provisions for the governing of the internal affairs of this corporation shall be as provided a comprehensive set of by-laws.

PROVISION VI.




