First: That the name of said corporation is "The Swedish Evan-gelical Lutheran Westdala Church".

Second; That the purposes for which it is formed are to carry on, support and maintain the worship of Almighty God in accordance with the customs and usages of the Swedish Evangelical Lutheran Church, and the constitution of the Lutheran Augustana Synod.

Third: That the place where its principal business is to be transacted, shall be Vollmer, Latah County, State of Idaho.

Fourth; That the term for which it is to exist is fifty years from and after the date of its corporation.

of whom shall be elected on the first Monday after the first day of January of each year, and shall hold their office for the term of three years, and until their successors are elected and qualified.

Sixth; That on the 21-day of January A.D. 1895, at Vollmer Latah County, State of Idaho, there was an election held by the members of the above named association for the purpose of electing Directors for said association, and that a majority of said members were present and voted at said election.

Seventh. That Lawrence Johnson, Carl Andrew and John Johnson were the officers that were chosen by said association to conduct the aforesaid election, and that they did conduct the said election.

Righth: That the names and residences of those who were elected at said election for the first Directors, are: (Cof Olsow residing at Vollmer, Latah County, State of Idaho, chosen for the term of three years, from the first Monday in January, : Afril Johnson residing at Vollmer, Latah County, State of Idaho,
