## CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION OF ROCK ROAD SPRINKLER IRRIGATION CORPORATION

BE IT REMEMBERED, That at a special meeting of the shareholders of Rock Road Sprinkler Irrigation Corporation, called pursuant to written notice of the time, place and purpose of said meeting, held at the Victor School at Victor, in the County of Teton,
State of Idaho, on the 25th day of September, 1980, which meeting as
will hereinafter more particularly appear from the affidavit of the
President and Secretary of the said corporation hereto attached, was
duly and legally called, and there was included in the notice of
said special meeting, proposals to amend the Articles of Incorporation of the corporation, as hereinafter specified, resolutions were
passed and adopted by the vote of the holders of two-thirds of the
voting power of all shareholders of Rock Road Sprinkler Irrigation
Corporation, to the end and purpose that said Articles of Incorporation are amended in the following particulars:
