ARTICLES OF INCORPORATION
OF THE
GRIDLEY ISLAND WATER ASSOCIATION

We, the undersigned, incorporators, hereby associate ourselves together to form and establish a corporation not for profit pursuant to Chapter 10, Title 30, Idaho Code.

FIRST: The anme of the corporation is GRIDLEY ISLAND WATER ASSOCIATION, INC.

SECOND: The location of its principal place of business is Hagerman, Idaho.

THIRD: The location of its registered office in this state is Hagerman, Idaho.

FOURTH: The name and address of its resident agent in this state is John LeMoyne, Hagerman, Idaho.

FIFTH: This corporation is not organized for profit and the objects and purposes to be transacted and carried on are to develop, construct, maintain and supply domestic water for all members of the association.

The corporation shall not have authority to issue capital stock but shall have the authority to issue certificates of membership providing that the rights and interests under each membership certificate shall be unequal. Each member shall have one vote for each platted lot purchased in the Gridley Island Subdivision.

SIXTH: The conditions of membership is the purchase and continued ownership of real property within the Gridley Island Subdivision as it appears of record in the office of the County Recorder of Gooding County, Idaho.

SEVENTH: The amount of capital with which this corporation will commence business is zero (0).
