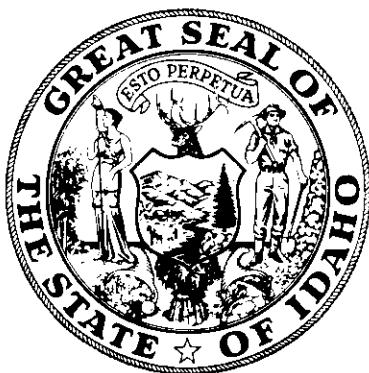

The undersigned, all of whom are natural persons of full age and citizens and residents of the State of Idaho and the United States of America, for the purpose of forming a corporation under the laws of the State of Idaho, hereby certify and declare:

ARTICLE I

The name of this corporation shall be LAW OFFICES, WHIPPLE & BYINGTON, CHARTERED.

ARTICLE II

The purposes for which it is formed are:

To provide professional legal services to the public and such other lawful business for which corporations may be incorporated.

ARTICLE III

The duration of the corporation shall be perpetual.

ARTICLE IV

The total authorized number of shares of this corporation shall be one thousand (1000) shares with no par value, all of the same class and all having the same relative rights, voting power, preferences and restrictions on the sale and transfer of the same as set out in the By-Laws of the corporation.




