

Certificate of Incorporation of the Alturas Pack Trail Company

Know all men by these presents
that we Daniel McLaughlin Julius
Newberry and J. A. Sidebottom
by virtue of "An Act Concerning
Corporation" passed at the first
Session of the Legislative Assembly
of the Territory of Idaho, and
Approved by the Governor January
4th 1864 do hereby declare and
Constitute ourselves a body politic
and Corporate under the name
and style of the Alturas Pack
Trail Company, The object of
the Company is to build and
maintain a Pack Trail from
Idaho City, Boise County Territory
of Idaho to Esmeralda Alturas
County in said Territory, Crossing
the Middle Fork of Boise, North
Fork of Boise river and all other
Streams on the route at the most
practicable points and to build all
necessary bridges dams and embank-
ments on the line of said Pack
Trail, and to charge and collect

toll for travel on said road.

The amount of the Capital Stock of said Company shall be Ten Thousand Dollars to be divided into One Hundred Shares of one Hundred dollars each. The term of the existence of said Company shall be fifty years, and the principal place of business shall be Esmeralda in Plumas County Idaho Territory. The number of trustees shall be three - at present Daniel McLaughlin, Julius Newbury and J. A. Tidbottom.
