

ARTICLES OF INCORPORATION OF LAKESIDE CHRISTIAN CHURCH, INC OF WINCHESTER, IDAHO

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned members of the LAKESIDE CHRISTIAN CHURCH, of Winchester, Idaho, all being over the age of majority, and pursuant to the express desires and direction of the membership of said Church do hereby, under and by virtue of the laws of the State of Idaho, and particularly the provisions of Title 30, Chapter 3, of the Idaho Code, associate ourselves together to form a corporation and for that purpose do certify as follows:

1. The name of this corporation shall be LAKESIDE CHRISTIAN CHURCH, INC. of Winchester, Idaho.

2. That the corporation is a non-profit corporation and is created for the charitable, benevolent, religious, and educational purposes and shall have for the accomplishment of such purposes the following particular powers and authority, to-wit:

A. To establish and maintain a place or places together with the necessary facilities for use as a place of public worship in the City of Winchester, Lewis County, Idaho, or in such other location as the members shall deem proper.

B. To establish and provide facilities for religious instruction and to further religious and charitable work and provide for the social welfare of its members and the community in which such facilities may be located.

C. To acquire by purchase, gift or any other lawful means and to own, hold, manage, lease or exchange both real and personal property; to erect such buildings, memorials or structures as may be necessary for the fulfillment of the objects and purposes of this corporation and to borrow money and secure the repayment of the same by pledges, mortgages or other lawful obligation of the whole or any part of the property of said corporation.

D. To receive and accept donations, gifts or bequests and to do all other things necessary and proper for the accomplishment of the purposes set forth herein.

3. This Corporation shall have perpetual existence.

ARTICLES OF INCORPORATION

4. The street address and post office address of the initial registered office of the Corporation is and shall be 605 Nez Perce Street, P.O. Box 254, Winchester, Idaho 83555. The initial registered agent at such address is Vaneta Marks, Secretary.

5. This Corporation is not organized for pecuniary profit and it shall not have or issue capital stock, but shall be supported by gifts, bequests, contributions, benefits and dues of its members. Membership in the Corporation shall not entitle the person to any interest whatsoever in the assets of the Corporation, but only to participate in the management of the affairs of the Corporation through meetings of the members legally called, and no part of receipts or income of said Corporation shall inure to the benefit or be distributed to any individual member, members or officers of the Corporation.

6. This Corporation shall have members who shall have the management of its affairs, vested in its members pursuant to Section 30-314(c) of the Idaho Code. By resolution, the Chariman and attested by the Secretary shall be empowered to transfer real property of the Corporation. Further, members shall have control of the promotion, operation and maintenance of said Corporation, together with its spiritual direction, and shall elect annually its officers. The President, or appropriate officers, shall preside at the meetings of the members.
