ARTICLES OF INCORPORATION
OF A 1 35
TRINITY CHRISTIAN SCHOOL, INC.

# ARTICLE I

The name of this corporation shall be TRINITY CHRISTIAN SCHOOL, INC.

# ARTICLE II

This corporation shall be a nonprofit corporation organized for the purpose of providing a christian educational system, including the operation of schools, adult education programs, programs supplementary to the public education system, day care or nursery educational programs and any and all other educational activities and all activities related thereto.

# ARTICLE III

This corporation is organized exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code and the laws of the State of Idaho. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code. No part of the net earnings of the corporation shall inure to the benefit of any member. This corporation is not empowered to engage in activities which are not in furtherence of a tax exempt purpose as provided under Section 501(c)(3) of the Internal Revenue Code. Upon the winding up and dissolution of the corporation, after paying or adequately providing for the debts or obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code, such organization to be selected by the board of directors of the corporation.

## ARTICLE IV

The existence of this corporation shall be perpetual.

# ARTICLE V

The management of the corporation shall be vested in the board of directors who shall be elected by the members of the corporation as is further set forth in the By-Laws of the corporation.

# ARTICLE VI

The post office address of the corporation's initial registered office is 202 Idaho Street , American Falls, Idaho 83211. The corporation's initial registered agent shall be Lyle D. Eliasen at said address.

## ARTICLE VII

The number of directors constituting the corporation's initial board of

directors is five (5), whose names and addresses are:

# ARTICLE VIII

At the first annual meeting of the members of the corporation, the number of directors shall be increased and the number of directors shall be as is thereafter established by the By-Laws of the corporation, but shall be no less than five nor no more than nine directors in numbers.

# ARTICLE IX

These Articles of Incorporation shall be amended only upon the adoption of a resolution setting forth the proposed amendment by 2/3 majority vote of the board of directors and after approval thereof by the members having voting rights as set forth in the By-Laws of the corporation.

# ARTICLE X

This corporation, and any schools or programs shall admit students of any race and accord to them all the rights, privileges, programs and activities generally accorded or made available to its students and does not discriminate on the basis of race, color and/or national or ethnic origin in administration of its educational programs, policies, admissions policies, scholarship and loan programs, and athletic and other school administered programs.
