Pursuant to the provisions of Section 30-1-61 of the Idaho Code, the undersigned adopts the following Articles of Amendment to the Articles of Incorporation:

FIRST: The name of the corporation is CAPITOL SILVER MINES, INC.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation at the special meeting of the shareholders held on December 21, 1994;

Article V of the Articles of Incorporation of CAPITOL SILVER MINES, INC. was amended to read in its entirety as follows:

"ARTICLE V

The amount of the capital stock of this corporation shall be Two Million Dollars (\$2,000,000.00) divided into Twenty Million (20,000,000) df the par value of Ten Cents (\$0.10) per share.
