Rock Creek Firefighters Association, Inc.

Article II

The Rock Creek Firefighters Association, Inc., is a group of individuals that provide a variety of emergency mitigation activities within the Rock Creek Rural Fire Protection District. These activities include but are not limited to fire suppression, public safety, public education, medical emergencies and other incidents as they arouse. The Association shall also provide charitable activities to the general public. These activities include but are not limited to assisting local clubs, organizations, schools and individuals to provide for the general welfare and safety of the general public. These activities may include labor or monetary assistance. The activities of the association shall also include the education of the general in the arena of fire safety, medical treatment, and any other activities that are associated with the operation of emergency services.

Article IV

Upon dissolution, all assets, real and monetary, shall be transferred to The Rock Creek Rural Fire Protection District or a non-profit entity or entities within the boundaries of the Rock Creek Rural Fire Protection District.
