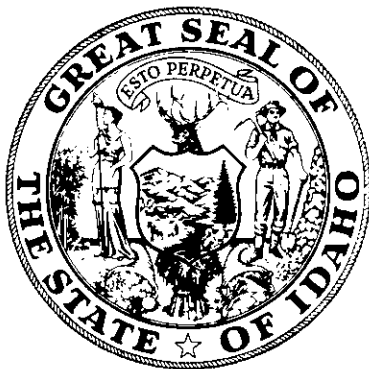

AMENDMENT TO ARTICLES OF INCORPORATION

1. The name of the corporation is B & B INDUSTRIAL SUPPLY, INC.

2. The following amendment to the Articles of Incorporation was adopted by the Shareholders of B & B INDUSTRIAL SUPPLY, INC., on the 27th day of August, 1990, in the manner prescribed by the laws of the State of Idaho, and in the following form.
