## OPEN BIBLE TABERNACLE, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned being natural persons of legal age and citizens of the United States of America and bona fide residents of the State of Idaho, do hereby associate ourselves together for the purpose of forming a corporation under the provisions of Chapter 11, Title 30 of the Idaho Code, and do hereby adopt the following Articles of Incorporation, to-wit:

#### ARTICLE I.

That the name of said corporation shall be OPEN BIBLE TABERNACLE, INC.

#### ARTICLE II.

That the term of existence of said corporation shall be perpetual.

#### ARTICLE III.

That the location and post office address of its registered office in this state and the principal place of worship shall be Smelterville, Shoshone County, Idaho.

## ARTICLE IV.

OBJECT - The object of this church shall be the propagation and dissemination of the Gospel of Jesus Christ through the preaching, teaching and living of the Full Gospel Message as outlined in the Articles of Faith, Constitution and By-laws of the Open Bible Standard Churches, Inc., having its principal place of business in Des Moines, Iowa, and shall be based on the Bible as the inspired word of the living God. This corporation shall have power to purchase, lease, and construct churches, schools and other building structures useful in connection with the carrying out of the purposes and objects of this corporation.

## ARTICLE V.

DEBIS - The corporation shall convey no real estate or incur indebtedness

secured by liens on real or personal property of this church without having obtained the written consent of the District and Divisional Superintendent of the Open Bible Standard Churches, Inc., or its duly authorized successors, and shall also have the affirmative vote of 2/3 of voting members present at a duly authorized meeting of the members of the church authorizing such conveyance, indebtedness, or lien. When so permitted and authorized it shall have power to convey, to borrow money, and execute written evidence of indebtedness therefore, to issue bonds and debentures, and secure them by mortgage, trust deed or otherwise.

#### ARTICLE VI.

MEMBERSHIP - The membership of this corporation shall consist of those individuals who are twelve years of age and over, who have been officially and publicly received into the membership of the church and who are in accord with the express purpose of this church, as set forth in the Policies and Principles of Open Bible Standard Churches, Inc. Voting privileges shall be allowed only to members who are 18 years of age or over, and who have been members for a period of at least thirty days.

## ARTICLE VII.

OFFICERS - The officers of this church shall be as follows: Pastor;
Board of Elders of not less than three nor more than seven members, including the Pastor as chairman, who shall be the directors of this corporation;
Secretary and Treasurer. The duties and terms of office shall be as provided by the By-laws of this corporation. The following persons shall be the officers of this corporation until their successors are elected:

#### ARTICLE VIII.

The number and the above named Board of Directors were decided upon and duly elected at a meeting of the members of the Open Bible Tabernacle of Smelterville, Idaho held on the 19th day of June, 1961, at 7:30 o'clock p.m. (Mountain Standard Time) at the Open Bible Tabernacle in the village of Smelterville, Shoshone County, State of Idaho, who met and decided to form this religious corporation; that all of the members of the group present voted in the election and by a majority vote elected the said Board of Directors hereinbefore named; that all directors are of lawful age and residents of Kootenia and Shoshone Counties, State of Idaho. ## ARTICLE XI.

BY-LAWS - By-laws of this corporation shall consist of Article IV of the by-laws of Open Bible Standard Churches, Inc., having its principal place of business in Des Moines, Iowa, and such additional by-laws as may be passed by a 2/3 vote of the members present at any business meeting of this corporation not inconsistant herewith.

#### ARTICLE XII.

PERSONAL LIABILITY - No member of this corporation shall be liable for the debts of the corporation. Private property of the members of the corporation shall be exempt from corporate debts and liability.

## ARTICLE XIII.

NON-PROFIT RELIGIOUS CORPORATION - This corporation shall be a non-profit religious corporation without stock or fixed capital and members of the corporation shall be those duly admitted to membership as specified in Article VI.
