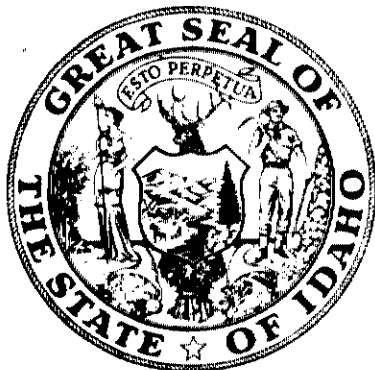

ARTICLES OF INCORPORATION

OF

HARRIS, INC., GOVERNMENT SERVICES CONTRACTOR

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Harris, Inc., Government Services Contractor.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful retail or wholesale business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have the authority to issue is 50,000 at a par value of \$1.00.

FIFTH: Provisions denying preemptive rights are none.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are none.

SEVENTH: The address of the initial registered office of the corporation is 2309 Annett Street, Boise, Idaho and the name of its initial registered agent at such address is 2309 Annett Street, Boise, Idaho. *R/A Paul Harris as per gph*
