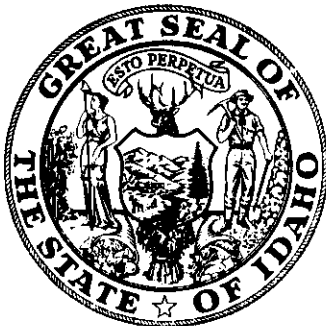

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF CA CO.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is: CA CO.

SECOND: The following amendments of the Articles of Incorporation were adopted by the Shareholders of the corporation on December 1, 1994, in the manner prescribed by the Idaho business Corporation Act:
