ARTICLES OF INCORPORATION

We the undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is INDEPENDENCE SERVICES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may incorporated under the Idaho Business Corporation Act.

FOURTH: Aggregate number of shares for which the corporation shall have authority to issue is two shares, such shares to consist of one class only and shall have a par value of ONE DOLLAR (\$1.00) for each share.

The aggregate par value shall be \$1.

FIFTH: The address of the initial registered office of the corporation is 3664 Steven Place, Coeur d'Alene, Idaho 83815 and the name of its initial registered agent at such address is Gary A. Edwards.

SIXTH: The number of directors constituting the initial board of directors of the corporation is two, and the name and address of the person who is to serve as director until the first annual meeting of shareholders or until their successor is elected and shall qualify is:

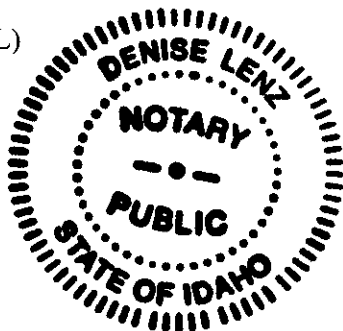
