ARTICLE I Name

The name of the Corporation is MyState USA, Inc.

#### ARTICLE II Authorized Shares

The aggregate number of shares of the Corporation is authorized to issue shall be fifty million (50,000,000) shares all of which shall be common voting stock.

#### ARTICLE III Registered Office and Agent

The registered office of the Corporation is 1458 S. Eagle Flight Way, Boise, ID 83709, and its registered agent at that address is Richard W. Haener.

#### ARTICLE IV Treasury Shares

This corporation shall not vote its treasury shares, except that it may vote treasury shares held in a fiduciary capacity.

#### ARTICLE V Redeemable Shares

Redeemable shares are not entitled to vote after notice of redemption is mailed to the holders and a sum sufficient to redeem the shares has been deposited with a bank, trust company, or other financial institution under an irrevocable obligation to pay the holders the redemption price on surrender of the shares.

#### ARTICLE VI Board of Directors

All corporate powers shall be exercised by or under the authority of, and the business affairs of the corporation managed under the direction of, its board of directors. The number of directors shall be fixed by the by laws but shall never be less than 5 and no more than 11.

#### ARTICLE VII Special Meeting of Shareholders

Special meetings of shareholders shall be held (a) on call of the corporation's board of directors; or (b) by the president of the Corporation; or (c) by the written demand of the holders of at least fifteen percent (15%) of all votes entitled to be cast on any issue proposed to be considered at a special meeting, said demand to be signed, dated, and delivered to the Corporation with a description of the purpose for which the meeting is to be held.

#### ARTICLE VIII Indemnification

The corporation shall indemnify the directors and officers of the corporation to the fullest extent permitted by the Idaho Business Corporation Act, as the same exists or may hereafter be amended but, in the case of any such amendment, only to the extent that such amendment permits the corporation to provide broader indemnification rights than the Idaho Business Corporation Act permitted the corporation to provide prior to such amendment.

### ARTICLE IX Limitation of Liability

No director shall be liable to the corporation or its stockholders for monetary damages for breach of fiduciary duty except liability for: (i) the amount of a financial benefit received by said director to which he is not entitled, (ii) an intentional infliction of harm on the corporation and / or its shareholders; or a violation of Idaho Code § 30-1-33.

#### ARTICLE X Amendment of Articles

That the Articles of Incorporation may be amended by (a) a vote of 2/3 of the Board of Directors and a written consent of a majority of the Shareholders, or (b) by a vote of the majority of the Shareholders at an annual or special meeting of the Shareholders.
