KNOW ALL PEOPLE BY THESE PRESENTS:

We, the undersigned, citizens of the United States and residents of the State of Idaho and City of Meridian or vicinity in Ada County, and members of CHRIST LUTHERAN CHURCH, hereby associate ourselves together for the purpose of forming a religious corporation pursuant to Chapter 3 of title 301, Idaho Code, and all acts supplemental thereto and amendatory thereof, and we hereby certify:

That at a meeting of the members of said church held at the Christ Lutheran Church in Meridian, Ada County, Idaho at the hour of 11:45 o'clock a.m. on the 18th day of April, 1993, for the purpose of forming a religious corporation of the members of said church under the name of CHRIST LUTHERAN CHURCH OF MERIDIAN, IDAHO, INC., a religious corporation, providing that said corporation shall have perpetual succession, adopting bylaws for said corporation and for the purpose of transacting any and all other business that the members present deem it expedient to transact in connection with said incorporation, prior to which meeting the time and place thereof was given in the manner and form required by Section 30-324, Idaho Code, by publicly announcing the date and place of such meeting on the two (2) successive Sundays prior to the date of such meeting, at which meeting, a majority of the members of said church elected and authorized the under signed directors to adopt and certify the following articles of incorporation, to-wit:

## ARTICLE I

The name of this corporation shall be CHRIST LUTHERAN CHURCH OF MERIDIAN, IDAHO, INC.

## ARTICLE II

CHRIST LUTHERAN CHURCH OF MERIDIAN, IDAHO, INC. shall be a non-profit corporation. The duration of this corporation shall be perpetual.

## ARTICLE III

The objects and purposes for which this corporation is formed shall be and are as follows:

To establish and maintain a church in the City of Meridian, County of Ada, State of Idaho, and in connection therewith a suitable and customary organization for the purpose of public worship and religious training under the protestant faith, subject, however, in its government to The Lutheran Church - Missouri Synod; to receive, hold, and enjoy gifts, devises and legacies; to borrow money; to execute and issue notes and bonds evidencing its indebtedness and to secure indebtedness by pledge, mortgage or other encumbrances of its property; to rent and lease real property; to do any and all things convenient and incidental to the purposes herein expressed; and generally to have and exercise all such powers as are by law conferred on corporations of like character and without in any particular limiting any of the objectives or purposes or powers of the corporation, the objectives and purposes of the corporation shall be from time to time to do one or more or all of the acts and things herein set forth, and all such acts, things and business in any manner connected therewith or necessary, incidental, convenient or auxiliary thereto or calculated, directly or indirectly, to promote the interests of the corporation or the members thereof or to enhance the value of any of its property or rights as such corporation may lawfully do; and in carrying on its objectives and purposes or for the purposes of attaining any of its objects, to do any and all things and exercise any and all other powers not prohibited by law or the standards and practices of The Lutheran Church - Missouri Synod.

#### ARTICLE IV

The initial registered office of this corporation shall be CHRIST LUTHERAN CHURCH, 1406 W CHERRY LANE, MERIDIAN ID 83642, and its initial registered agent at such address shall be Gerald Rohnert.

#### ARTICLE V

The members of this corporation shall be all persons who are now or who may hereafter become members of CHRIST LUTHERAN CHURCH of Meridian, Idaho.

#### ARTICLE VI

The business of this corporation shall be managed and conducted by a Board of Directors of at least four (4) persons, and the number, qualifications, terms of office, manner of election, time, place and manner of calling meetings shall be prescribed by the bylaws. The Board of Directors shall have the management of the real estate and personal property of the corporation and shall be in charge of the promotion, operation and maintenance of the corporation, for the use of the members of this corporation and the properly constituted church authorities. The initial Board of Directors of this corporation shall be the four (4) members of the official Board of Directors of this corporation until the first annual meeting of this Corporation and until their successors are elected and qualified.

## ARTICLE VII

The following members of the Board of Directors duly elected on April 18, 1993 to serve as incorporators for the purpose of forming this non-profit corporation:
