

ARTICLES of INCORPORATION
of the

KNOW ALL MEN BY THESE PRESENTS: That we the under-
signed have this day voluntarily associated ourselves
together for the purpose of forming a corporation under
the laws of the State of Idaho and we hereby certify:

I.

That the name of said Corporation is the "TWIN FALLS
NEWS PUBLISHING COMPANY, LIMITED".

II.

That the purposes for which it is formed are to carry
on the business of printing and publishing a newspaper
or newspapers, doing job printing and binding, to purchase
own and hold news franchises and to do all manner of
business related to the said publishing, printing and
binding business and to purchase and hold the necessary
property for it's purposes.

III.

That the place where it's principal business is to be
transacted shall be Twin Falls, Idaho.

IV.

That the term for which it is to exist is fifty years
from and after the date of it's incorporation.

V.

That the number of it's directors shall be three and
that the names and residences of those appointed for the
first year are:
