



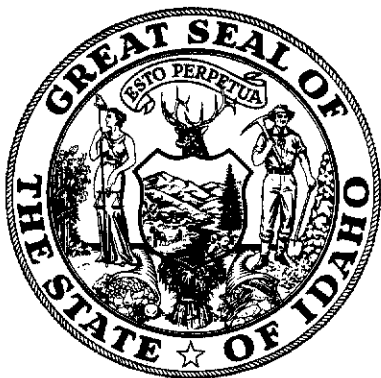
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

DAVID Wm. YON ENTERPRISES, INC.

DAVID Wm. YON, being over the age of eighteen (18) years of age and a citizen of the State of Idaho and the United States of America, for the purpose of forming a corporation under the Idaho Business Corporations Act, adopts the following articles of incorporation.

ARTICLE I

The name of this corporation shall be DAVID Wm. YON ENTERPRISES, INC.

ARTICLE II

The duration of this corporation shall be perpetual.

ARTICLE III

The purpose for which this corporation is organized is for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

ARTICLE IV

This corporation shall be capitalized for Fifty Thousand (\$50,000.00) Dollars. The total authorized stock of this corporation shall be divided into Five Hundred Thousand (500,000) shares, all of which shall be common stock with a par value of \$0.10 per share. Said shares shall be nonassessable and shall all be of the same class and every share of said stock shall be equal in all respects to every other said share.

ARTICLE V

This corporation shall not commence business until consideration of the value of at least Five Hundred (\$500.00) Dollars has been received for the issuance of shares.

ARTICLE VI

The owners of shares of stock of this corporation shall not be entitled to preemptive rights to subscribe for or purchase any part of new or additional issues of stock or securities convertible into stock of any class whatsoever whether now or hereafter authorized, and whether issued for cash, property, services, by way of dividends, or otherwise.

ARTICLE VII

The Board of Directors shall have full power to adopt, alter, amend, or repeal the bylaws or adopt new bylaws. Nothing herein shall deny the concurrent power of the shareholders to adopt, alter, amend, or repeal the bylaws.

ARTICLE VIII

This corporation reserves the right to amend, alter, change, or repeal any provisions contained in its articles of incorporation in any manner now or hereafter prescribed or permitted by statute. All rights of shareholders of this corporation are granted subject to this reservation.

ARTICLE IX

The number, qualifications, terms of office, manner of election, time and place of meetings, and powers and duties of the directors shall be prescribed in the bylaws, but the number of the first board of directors shall be

three (3), and they shall serve until the first meeting of shareholders and until their successors are elected and qualified, and their names and post office addresses are as follows:

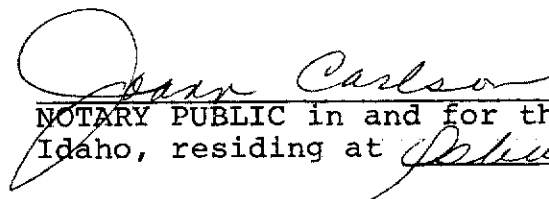
