ARTICLES OF INCORPORATION

OF RAGAN POLE COMPANY

KNOW ALL MEN BY THESE PRESENTS, that we the undersigned citizens of the United States of America, being each of full age, have this day voluntarily associated ourselves together for the purpose of forming a business corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

ARTICLE I.

The name of this Corporation shall be RAGAN POLE COMPANY.

ARTICLE II.

The purposes for which this Corporation is formed are as follows:

- (a) To engage in general manufacturing and processing and the distribution and sale at wholesale or retail of the products thereof, such activities to embrace any such business as will utilize the resources owned by or available to the Corporation, including, but not limited to, forest products of every kind and nature, minerals and mineral products, natural resources of every description, and any derivatives thereof; to acquire, own, operate, buy, sell, exchange, or lease manufacturing plants, mills, yards, facilities, stores, machinery, equipment, materials, sumplies and products necessary, useful or desirable in such manufacture or sale;
- (b) To engage in any lawful service or business, whether or not directly or indirectly related to any of the Corporation's other operations;

(c) To acquire, own, buy, sell, exchange, lease, mortgage or otherwise deal with real or personal property of any description whereever located. (d) To lend money for any lawful purpose, with or without security, and to take, hold and realize upon any property or thing of value pledged or hypothecated to secure the paiment thereof; (e) To borrow money for any purpose of this Corporation or for any lawful purpose directly or indirectly related thereto, and to secure the payment thereof with any property of the Corporation or by any other means whatever; (4) To purchase, lease, or otherwise acquire, in whole or in part, the business, good will, rights, franchises, stock and property, and to assume, in whole or in part, the liabilities and obligations, of any person, firm, association or corporation engaged in or authorized to be engaged in any business authorized to be conducted by this Corporation, or owning property desirable for its operations and to pay for the same in cash, in the stock or bonds of this Corporation, or otherwise, and to exercise all the powers necessary or incidental to the acquisition of, merger with, or operation of such business; (g) To enter into any contract, cooperative agreement or profit sharing plan with its officers or employees that the Corporation may deem advantageous or expedient; To exercise generally all of the powers lawfully exercised by business corporations, within the State of Idaho and elsewhere, whether or not related to the specific powers enumerated above, which specific powers shall not be regarded as limiting or restricting in any way the generality of this paragraph. - 2 -

ARTICLE III.

This Corporation shall have perpetual duration.

ARTICLE IV.

The location and postoffice address of the registered office and principal place of business of this Corporation shall be Plummer, Benewah County, Idaho; and the Corporation may have such other offices and places of business within or outside the State of Idaho as the directors shall, from time to time, determine.

ARTICLE V.

The authorized capital of this Corporation shall be Fifty Thousand Pollars (\$50,000), divided into fifty thousand (50,000) shares of common stock of a single class, with a par value of One Pollar (\$1.00) per share.
