ARTICLES OF INCORPORATION

OF

HEANEY PLUMBING, INCORPORATED

The undersigned, acting as the Incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is HEANEY PLUMBING, INCORPORATED.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated including, without limitation, a plumbing contracting business under the Idaho Business Corporation Act.
