## ARTICLES OF INCORPORATION OF THE CHAMBER NETWORK ASSOCIATION, INC.

U

fills The undersigned, acting as incorporators of a non-profess corporation under the Idaho Non-Profit Corporation Act, adopts the following Articles of Incorporation for such Corporation.

I

The name of the Corporations shall be CHAMBER NETWORK ASSOCIATION . INC.

ΙI

The period of its duration shall be perpetual.

SEV. OF STATE

III

The purposes for which this Corporation is organized are the following:

- A. Promote economic programs designed to strengthen and expand the Chambers within the region.
- B. Promote programs of a civic, social and cultural nature which are designed to increase the functional and aesthetic values of all communities involved.
- C. To provide a forum for the open discussion of all matters concerning our chambers and communities.

No part of the net earnings of the Corporation shall inure to the benefits of, or be distributed to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set

forth in the foregoing paragraph. No substantial part of the activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in any political campaign on behalf of any candidate for public office.

Additionally, the Corporation shall not carry on any other activities not permitted to be carried on either by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law) or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue law).

Upon dissolution of the Corporation, the officers shall, after paying or making provision for payment of all liabilities of the Corporation, dispose of all the assets of the Corporation either for the furtherance of the purpose of the organization or to such organizations which are organized and operated exclusively for charitable, educational, literary, or scientific purposes and which shall, at that time, qualify as a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue law). Any assets not so disposed of shall be disposed of by the District Court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as the Court shall determine.
