**RESTATED ARTICLES OF INCORPORATION
OF
STRATFORD NORTHWEST BUILDING SYSTEMS, INC.**

Pursuant to Idaho Codes §30-1-64, and pursuant to a duly adopted resolution of the shareholders and directors of the corporation dated December 1, 1995, we, the undersigned officers of STRATFORD NORTHWEST BUILDING SYSTEMS, INC. adopt the following restated Articles of Incorporation for such corporation:

FIRST: The name of the corporation is **STRATFORD NORTHWEST BUILDING SYSTEMS, INC.**

SECOND: The period of duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

The transaction of a business and any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

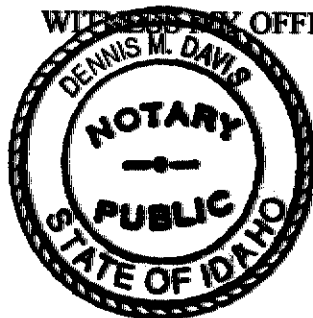
