Article 1st.

which shall be known as the
Corbett Slough Ditch Company
with all the Powers and privileges
allowed Corporations under
the Law.

Article 2nd

The object for which this Corporation
is formed is to take waters out
of Snake River in Bingham
County Idaho for domestic and
agricultural purposes to be used
on lands in Snake River Valley
to purchase and hold real estate
that may be necessary for the purposes
of this Corporation and not exceeding
the amount allowed by Law.

Art 3.

The Principal place of Business of this Corporation shall be Blackfoot, Bingham County Idaho and Where the office of the Company shall be kept.

The term of existence of this Corporation shall be fifty years from this date
