ARTICLES OF INCORPORATION OF 87 AUG 5 AM 8 47 HAGMAN CORPORATION

We, the undersigned, adult natural residents of the State of Idaho for the purpose of forming a corporation under the laws of the State of Idaho, make and subscribe the following Articles of Incorporation:

ARTICLE I.

Name: The name of the corporation shall be Hagman Corporation.

ARTICLE II.

Period of Duration: The period of existence of the corporation shall be perpetual.

ARTICLE III.

Place of Business: The principal place of business of the corporation shall be Coeur d'Alene, Idaho.

ARTICLE IV.

Address of Registered Agent and Office: The registered office of the corporation is 2867 Masters Drive, Coeur d'Alene, Idaho, 83814 and the regestered agent at that address is Daniel Hagman.

ARTICLE V.

Purposes: This corporation is organized for the purpose of transacting, within and without the State of Idaho, any business not prohibited by law.

ARTICLE VI.

Powers: The corporation shall have and exercise all those general powers enumerated in TITLE 30-1-4 IDAHO BUSINESS CORPORATION ACT.

ARTICLE VII.

Capital Contribution: The corporation shall not commence business until consideration of the value of at least One Thousand Dollars has been received for the issuance of its shares.

ARTICLE VIII.

Pre - emptive Rights: The pre-emptive right of the corporations shareholders to acquire additional or treasury shares of the corporation shall be neither limited nor denied.

ARTICLE IX.

Limitation on Transfer of Shares; No shareholder of the corporation shall during his lifetime transfer, encumber or dispose of all or any portion of his stock interest in the corporation, except that if a shareholder should desire to dispose of any of his stock in the corporation during his lifetime, he shall first offer in writing to sell all of his stock to the

corporation at a price equal to the then book value of such shares of stock. Any shares not purchased by the corporation within 30 days after receipt of such offer in writing shall be offered at the same price to the other shareholders, each of whom shall have the right to purchase such portion of the remaining stock offered for sale as the number of shares owned by him at such date shall bear to the total number of shares owned by all the other shareholders, excluding the selling shareholders; provided, however, that if any shareholder does not purchase his full proportionate share of the stock, the balance of the stock may be purchased by the other shareholders equally. If the stock is not purchased by the corporation or the remaining shareholders within 60 days of the receipt of the offer, the shareholders desiring to sell his stock may sell it to any other person, but shall not sell it without giving the corporation and the remaining shareholders the right to purchase such remaining stock at a price and on the terms offered to such other person.

ARTICLE X.

Internal Affairs: The internal affairs of the corporation shall be regulated in accordance with by-laws adopted by a majority of the shareholders.

ARTICLE XI.

Number and Type of Shares Authorized: The aggregate number of shares which the corporation is authorized to issue is Ten Thousand, all of which shall be common voting stock having neither par nor stated value.

ARTICLE XII.

Directors: The number of directors constituting the initial Board of Directors of the corporation is three; the names and address of the persons who are to serve as directors until new directors are duly elected and shall qualify are:
