AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **Twin Falls,** in the County of **Twin Falls,** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

OF

AIRPORT FREE WILL BAPTIST CHURCH

KNOW ALL MEN BY THESE PRESENTS:

WE, THE UNDERSIGNED, being members of the Airport Free Will Baptist Church, Twin Falls, Idaho, do hereby associate ourselves together for the purpose of forming a religious non-profit corporation to carry on, manage and control the business affairs of said Church and do hereby certify and represent as follows:

I.

That for more than two weeks prior to the organizational meeting hereinafter described, due and legal notice of said meeting was given by posting a notice of said meeting on the front door of the Disabled American Veterans Hall located at the intersection of Shoup and Harrison Street, in the City and County of Twin Falls, State of Idaho, and by publication thereof in the Twin Falls Times News, a daily newspaper published at Twin Falls, Idaho.

II.

That as specified in said notice, said organizational meeting was held at the hour of 7:30 P.M. on the 20th day of May, 1966 at said Disabled American Veterans Hall; that eight (8) persons, all members of said church, attended said meeting; that Orville Carpenter presided at said meeting and the following resolutions were offered, discussed and voted upon.

RESOLUTION #I.

BE IT RESOLVED, that the Airport Free Will Baptist Church be incorporated as a religious and benevolent corporation pursuant to the provisions of the Laws of the State of Idaho.

RESOLUTION #II.

BE IT RESOLVED, that the Board of Directors of this Church be composed of Five (5) members of this church who shall have charge of the real property and the operation of the affairs of the church and said corporation.

III.

Both of the foregoing resolutions were approved by the membership. A Board of Directors was duly elected and they were instructed to have counsel prepare the necessary documents and to take such further action as is necessary to incorporate said church pursuant to said provisions of Section 30-1101, Idaho Code.

IV.

That the name of this corporation shall be the AIRPORT FREE WILL BAPTIST CHURCH, INC.,

V.

That the purposes for which said corporation is formed are to promote and advance the preaching and teaching of the gospel of the Lord Jesus Christ in accordance with the faith and practices of the Free Will Baptists and in accordance with the teachings, rules, laws and precepts of the National Association of Free Will Baptists, and for the purpose of accomplishing said objects shall have the following powers, to-wit:

- a) The power to purchase, receive and hold real or personal property of all kinds.
- b) The power to grant, bargain, sell, convey or dispose of any real or personal property.
- c) The power to make, execute, and deliver deeds, bills of sale, mortgages, liens or pledges of real or personal property.
- d) The power to borrow money of any person, firm or corporation and to issue bonds, debentures, or obligations of this corporation from time to time for any of the obligations and purposes of the corporation and to secure the same by mortgage, pledge, deed of trust or by any other lawful means.

- e) To purchase material and hire labor for the erection of a building or buildings for the use of said corporation.
- f) To maintain accounts with any bank of their choosing, to make deposits therein and withdrawals therefrom; to accept endowments, gifts, legacies and bequests of all sorts, both real and personal; to manage and control property owned by others and to invest funds for the benefit of the membership of said church.
- g) To do any and all things necessary, suitable and proper for the accomplishment of any of the purposes or for the attainment of any of the obligations or for the exercise of any of the powers herein set forth, whether herein specified or not.

VI.

That the location and post office address of said corporation shall be Route #1, Twin Falls, Idaho, situate about one and one half miles South of the South City Limits of the City of Twin Falls, Idaho on the Airport Road.

VII.

This corporation shall have perpetual existence unless sooner voluntarily dissolved.

VIII.

That the number of directors of said corporation shall be five (5); that said Board of Directors shall have the management and control of the real property owned by said corporation as well as the management and control of the operation, promotion and affairs of said church.

IX.

That this corporation shall have no capital stock, but that each member of the Airport Free Will Baptist Church of Twin Falls, Idaho, shall have one vote in the election of the officers of said corporation. That the incorporators of this corporation and the persons chosen as the members of the first Board of Directors of said corporation are the following named persons:

Orville Carpenter, Jack Johnson, Virgil Andrews, Clovis Reed and John Holcomb; that each of said persons reside at Twin Falls, Idaho.

X.

That each of the signatories hereto are citizens of the State of Idaho and of the United States of America; that each of them are of legal age and competent to act as incorporators of this corporation.
