CERTIFICATE OF AMENDMENT OF THE ARTICLES OF INCORPORATION

OF

GEN STATE LUMBER COMPANY

At a special meeting of the stockholders of Gem State Lumber Complay, a corporation organised and existing under and by virtue of the laws of the State of Utah, duly called and held at the office of the Company, room 1112 Newhouse Building, Salt Lake City, Utah, on the 12th day of December, 1927, at 10 e'cleck A.K., after notice and at which meeting there were represented either personally or by proxy the entire Three Thousand (1,000) shares of the issued outstanding shares of the Common Stock of the Corporation (having sole woting power) and at which meeting there was submitted the following resolution:

BE IT RESCLYED: That Article 7 of the Articles of Incorporation of Gem State Lumber Company as heretofore amended be and the same is hereby amended so that the first paragraph thereof shall read as follows:

"The amount of the capital stock of this corporation shall be Eight Bundred Thousand Dollars (000,000.00) divided into Eight Thousand (8,000) shares of the par value of One Hundred Dollars (\$100.00) per share. Of said sapital stock Four Thousand (4,000) shares thereof, amounting to Four Hundred Thousand Dollars (\$400,000.00) shall be common stock and Four Thousand (4,000) shares thereof, amounting to Four Hundred Thousand Dollars (\$400,000.00) shall be Preferred Stock. From time to time the Preferred Stock and the Common Stock may be increased according to law, and may be issued in such smounts and proportions as shall be determined by the Board of Directors, and as may be permitted by law, except that in no case and at mo time shall the amount of the issued Preferred Stock be in excess of the amount of the issued Common Stock. The holders of Preferred Stock shall not be entitled to wote said stock and shall have no voice in the business or affairs of the corporation. The capital stock of this corporation shall be monassessable."

BE IT RESOLVED: That the remaining portion of said Article 7 be and remain as in the original Articles of Encorporation.
