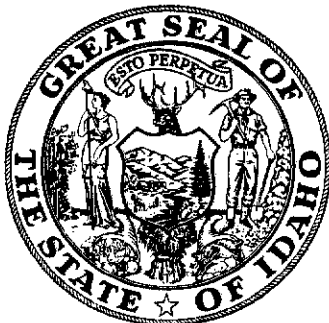

**ARTICLES OF INCORPORATION**  
**OF**  
**ENHANCEMENT ENTERPRISES, INC.**

The undersigned, acting as incorporator of a corporation under the Idaho Business Act, adopts the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation is "**ENHANCEMENT ENTERPRISES, INC.**".

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

**FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares, with a par value of \$1.00 per share.

**FIFTH:** There are no provisions denying preemptive rights.

**SIXTH:** The internal affairs of the corporation shall be governed by a duly adopted Code of Bylaws which shall be consistent with these Articles of Incorporation, and the laws of the State of Idaho.

**SEVENTH:** The address of the initial registered office of the corporation is Post Office Box 789, Priest River, Idaho 83856 (with a physical location of corner of Highway 57 and Highway 2, Priest River, Idaho 83856), and the name of the registered agent at such address is **Nick M. Lamanna.**
