ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF

LOCKHART LEASING CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

Pursuant to the provisions of Section 16-10-57 of the Utah
Business Corporation Act, the undersigned corporation adopts the fol-
lowing Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Lockhart Leasing
Corporation.

SECOND: The following amendment of the Articles of
Incorporation was adopted by the shareholders of the corporation
on Tuesday, the 16 day of August, 1966, in the
manner prescribed by the Utah Business Corporation Act:

ARTICLE I

The name of the corporation is: ZIONS LEASING
COMPANY.

THIRD: The number of shares of the corporation outstand-
ing at the time of such adoption was 10,000; and the number
of shares entitled to vote thereon was 10,000. There is
no provision for class voting.

FOURTH: The number of shares voted for such amendment was
10,000, and no shares voted against such amendment.

FIFTH: The amendment does not provide for exchange, re-
classification or cancellation of issued shares.

SIXTH: The amendment does not change the amount of stated
capital.
